Email sent by Cox on 2/28/2024 to law enforcement, city council, city employees, the City Ethics examiner, and CC:ing Jennifer Ellison.

I had asked Elizabeth Wennstrom to accompany me to my Protective Order hearing as a friend and colleague, and had asked that she be allowed to speak to the background of Cox's involvement to illustrate Cox is not simply a disinterested "Victim's Advocate" in this case as she is claiming.

This seems to be a case of witness intimidation, as well as harassment of me.

The email included several photographs of me and others, taken in the hallway outside and as we were entering the courtroom. These photographs were taken without my knowledge or permission, and were sent to a large number of people and posted online.

Today, 2-28-2024, Councilwoman Libby Wennstrom attempted to intimidate me and shut down my free speech rights yet again.

On 2-20-2024, I filed a protective order for a vulnerable adult named Jenny Ellison. This was in regard to Jenny's relationship and abuse from Kevin Schooler, lead operator of Salish Rescue and former boyfriend of Libby. CM Libby Wennstrom was not a party to the case whatsoever, nor a witness to the abuse that I know of. Libby herself had been abusive to Jenny, who was a Salish Rescue Volunteer.

There was a hearing today for this delicate matter. I am working with several government agencies, APS, a Detective, Social Worker, and the Attorney General on these matters to ensure the safety of a woman who has been attacked many times and has been under extreme stress for a long time regarding these matters.

At the hearing at 9am this morning, Superior Court Jefferson County, WA Libby showed up with All of Salish Rescue, the same people who shut down our Free Speech event, bullied us, intimidated us on August 15th, 2022.

CM Libby Wennstrom has bullied Jenny in the past and had an affair with Jenny's then boyfriend Kevin Schooler.

Councilwoman Libby Wennstrom claimed in this ethics hearing process that she had a First Amendment right to Protest our Speech regarding Julie Jaman. Libby claimed she had a right to shut down Julie's speech outside the YMCA and to invite others to do so.

Libby claimed she had a First Amendment right to have Salish Rescue at our event intimidating us and a right to gather people in the community to protest us, scream at us, bully and threaten us and keep us from our due process at a city council meeting. We were silenced by a mob she incited. We were bullied, threatened, assaulted, robbed and intimidated. ALL this Libby claims she has a First Amendment Right to. Yet today she went to a court hearing that she was not a party to, and tried to testify that my online videos, my posting public hearings and public records and making fun of a politician was harassing her.

Councilwoman Libby Wennstrom shut down dozens of my Facebook pages and Groups, many I had for decades. She shut down 2 of my personal Facebook accounts and more. She claims a First Amendment right, but violates mine over and over.

Libby sets people up for long periods in jail with coordinated, organized tactics of her and Salish Rescue. Libby has endangered people, and rumor has it she even unalived someone, claiming it an accident. Libby has covered up rapes and other crimes. I have proved so much to city council in the Ethics Review process. I am afraid of Libby and her hired thugs. I have a right to speak out about her, about them.

Councilwoman Libby Wennstrom is a Danger to our Community. She covers up rapes, plots Arson, sets people up, bullies people, endangers people, intimidated and threatens people. So far she is completely above the laws that all other Jefferson County Citizens have to apply to. And she continually has Special Privilege and gives our Special Privilege to her friends.

This hearing today is a VERY serious Life Threatening matter, she had no business there, yet as a Port Townsend Councilwoman she showed up and brought all of Salish Rescue to gang up on and intimidate this woman, this victim.

I was/am the Petitioner in the case filing for a vulnerable adult as advised by Jeffcom911 and Detective Jorgenson. Libby showed up to intimidate me, bully me and tried to testify that I was harassing her with my Online Videos which is my First Amendment Right and she is a Public Figure.

I am working on books, a documentary, federal hate crimes, criminal complaints, and other projects and online content connected to the Press Conference Riot, backed by the City of Port Townsend and incited by CM Libby Wennstrom. I have every right to report on her, make fun of her, and create content that I want. And I also have the First Amendment right to create content regarding our other attackers such as Salish Rescue, Rowen DeLuna, Kevin Schooler, Alden Rohrer and others.

Libby does not have a constitutional, ethical or lawful right to intimidate me, bully me and shut down my online speech over and over. IT IS NOT OK.

Though my Ethics Complaint clearly was not taken seriously, I am still in the lawful process of the Complaint, I should not be harassed and threatened by Libby and she shows up at a private protective order hearing where she is not a party to, to intimidate and harass me, to accuse me of harassment and shut down my speech involving a court proceeding with a Jefferson County Judge and in defense of her Salish Rescue lead operator, her lover, her friend Kevin Schooler. That is not ok.

She was there in support of and giving Special Privilege to Kevin Schooler. Kevin tried to get the Judge to let her testify that I was harassing her with my online content. She is an elected public official, a public figure, she had no business at that hearing. The Judge denied her request to speak today, as the hearing was not about me but about the woman I was there to try and save her life, Jenny Ellison.

I realize those included in this email laugh at me, don't listen, and never take what I say seriously. However, one day it will happen to someone you care about, someone you feel deserves rights and then you will understand how bad this all really is. People are being hurt, laws broken, constitutional rights shut down, human and civil rights violated, and those in a position of authority to stop it, simply ignore it.

Though I am never listened to by Jefferson County authorities, I am still creating a record as Libby is dangerous and I fear for my life from her. She wants me jailed for posting videos about her. She is a Public Figure. Libby is **protecting a violent man to abuse women**. This is escalating and this email is a record that you all know how dangerous she is. I know you don't care about my life or my quality of life nor any of the victims I have stood for, just know what she is doing is creating so much stress and tension in our community that I am clearly not the only one that knows or suffers from her wrath.

Most likely Phil O., City Manager John Mauro, Mayor David Faber, City Council, Chief Tom Olson simply will say that Libby has a First Amendment right to shut down my First Amendment Right. It is not ok and as I seek justice outside of the rampant blind public corruption in Port Townsend. I want you all to know that Libby is trying to harass, bully, threaten and intimidate me and shut down my right to speech and to prevent a vulnerable adult with disabilities from getting protection from a man who assaulted her, financially and sexually exploited her, sold nude photos of her in the port, stole her property, endangered her life, tried to kill her by sinking a boat she was living on and more that I am working with authorities outside of the cities corruption on. And she is using all of Salish Rescue, her nonprofit to do it.
