Cox's harassment of me continues to escalate. In the 48 hours since my 2/28 protective order hearings, Cox has posted 36 new defamatory videos on YouTube alone – most of these are also cross-posted on other platforms. Almost all of these videos have my name listed as a search engine keyword; many of them defame me personally. Cox continues to fabricate new "crimes" I have supposedly committed, and now claims to be reaching out to other government agencies to discredit and attack me. This is all intentional, targeted harassment; this is not "victim advocacy" or "free speech."

Extreme, coordinated harassment, part of a larger pattern of harassment by Crystal Cox, Jenny Ellison, Braith Miller and Erik Wennstrom. Already have a 5-year protective order protecting me from Erik Wennstrom – this is continuing this same pattern of harassment, using others as a proxy. Situation is rapidly escalating and causing significant harm.

In the image filed by Cox, the document has been modified to remove my name and address as the buyer. The buyer field is blank, yet the document has been notarized. The original and correct document was filed as part of my 2/26/2024 response to Cox's petition, page 5 of Exhibit G. Ownership Documentation for Schooner Ninaa Ootakii.

Also on February 28, 2024, Cox surreptitiously photographed me (without my knowledge or permission) as I stood in the courtroom lobby and entered the courtroom for a Protective Order Hearing. She then took those photographs and published them on a variety of internet sites, and sent them to third parties, including sending them to Ellison, against whom I have a Temporary Protective Order. Supposedly Ellison is terrified of me – why is Cox, supposedly acting as a "Victim's Advocate" here, sending photos of me to Ellison? A copy of this email is attached as Exhibit A.



Also on February 28-29. Cox has published 36 more bizarre, defamatory videos since the 2/28/2024 hearing (as she has done nearly daily for weeks), using my name as a keyword for each of post so search engines find her content when someone searches for my name or for Salish Rescue.

One of these videos (posted 2/28/2024 after court date) specifically references my attendance at court.

Past Incidents. What happened in the past that makes you want a protection order? On February 22, 2024, I was served with a temporary protective order from a "vulnerable adult" petition filed by Crystal Cox on behalf of my former girlfriend and domestic partner, Jenny Ellison. The petition requesting that order contains numerous outright falsehoods and misrepresentations of fact, and is false in its very premise. Some troubling aspects of this petition:

Cox is not a disinterested "victim's advocate" Cox states in her own declaration (filed 2/28/2024, page 1) that she had been searching for me since August 2022, and that she was convinced, without knowing who I was, that I was, in her words "a violent, dangerous man." Cox has in fact been engaged in an active campaign of targeted harassment and defamation against me since at least November 2023, when she began illegally recording Erik Wennstrom's court hearings and posting them online.

Cox did not "accidentally" connect me with Erik Wennstrom and Salish Rescue by incidentally seeing me at a court hearing, as she claims in her 2/28/2024 declaration. Cox sought me out at the Race to Alaska in June of 2022, and asked me numerous questions about Salish Rescue. At that time, I introduced myself to her by name, though she did not tell me her name, and I did not realize who she was until later.

Jennifer Ellison in no way meets the definition of a Vulnerable Adult under RCW 71A.10.020 -she is a 43 year old woman who has lived independently and managed her own affairs for decades. She claims to be receiving Social Security Income because of a mental health condition – diagnosed as an adult – of dissociative identity disorder (DID) (commonly known as multiple personality disorder), which causes her to have "episodes" where she claims to be unaware of memories or actions of her "other" personalities. The 11/9/2022 police CAD Narrative included in Cox's petition's Exhibit 1 references this condition, noting that:

<u>"Subj. [Ellison] has severe multiple personality. Last contact Subj was a small child. This time she was "Anna" and had an Irish accent"</u>

In fact, Cox's petition on Ellison's behalf is an attempt to misuse the protective order process as part of a larger pattern of ongoing harassment. Ms. Cox is working for/with Erik Wennstrom, Jennifer Ellison, and Braith Miller in an organized, coordinated effort to harass and defame me and my Salish Rescue colleagues.

Since November 2024, Ms. Cox and her associates have posted DOZENS of defamatory videos and posts about me, making false allegations, and accusing me of a variety of crimes without evidence. I have had a protective order in place restraining Erik Wennstrom from harassing or contacting me since October 4, 2023; he has continued his harassment using Cox, Ellison and Miller as proxies.

On November 20, 2023, I became aware that Ms. Cox was posting numerous defamatory TikTok and YouTube videos about me, and making false statements about me on social media.

- Ms. Cox illegally recorded my victim impact statement in Erik Wennstrom's November 2, 2023 sentencing hearing, and posted it to YouTube with additional voiceover and commentary of her own.
- Cox did an "interview" with Jennifer Ellison and Braith Miller that was posted on YouTube in mid-November 2023, accusing me of numerous crimes.
- To date, Cox has posted over 400 harassing, defamatory videos to a YouTube channel devoted to defaming and harassing me and anyone associated with Salish Rescue or Port Townsend Government or local Law Enforcement.
- New derogatory content is posted every day. 36 more videos have been posted since in the 48 hours my 2/28/2024 hearing.

Dozens of videos and related posts have been cross-posted on other platforms, including TikTok, X (Twitter), Facebook, Instagram and others. New content is posted on a daily basis, using my name as a keyword for search engines. Cox appears in or provides commentary for nearly all of these videos, and has linked to them and posted related defamatory content on numerous social media accounts.

I have attached screenshots and links of a sample of this defamatory content as Exhibit B.

Some of the harassing videos posted on YouTube by Cox feature images and video could *only* have been obtained via being "hacked" from files I had shared with Elizabeth Wennstrom via Google Drive. At the time these were shared on social media, Erik Wennstrom was in jail. I believe this may represent an additional case of Computer Trespass by Cox and Ellison, where Cox and Ellison are in possession of images stolen from Elizabeth Wennstrom's electronic files. In her conversation with me on 8/31, Ellison admitted to being part of Erik Wennstrom's Computer Trespass efforts on Elizabeth Wennstrom's Google Drive account [District Court Case #2305760DV].

This situation is growing increasingly volatile, with an extensive history of the Cox, Ellison, Miller and Wennstrom making both direct and indirect threats, and with Erik Wennstrom's continued failure to surrender his firearms. This ongoing online harassment is damaging my reputation in the community and on the internet, affecting my relationships, and taking significant time away from my work. I have been attempting to simply ignore it, but this latest escalation – filing a weaponized protective order, which among other things prevents me from seeing my elderly stepfather – now necessitates a response.

I have spoken directly with Ms. Cox only once, when she approached me at Race to Alaska in June 2023, and appeared to be friendly and asked me questions about Salish Rescue. At the time, I had no idea who she was or her history of online defamation, extortion and extreme harassment.

I have never had ANY routine contact with Cox, and it is unclear why she is so obsessed with harassing and defaming me. She is actively following Erik Wennstrom's court hearings, and working with my former girlfriend Jennifer Ellison to create defaming accusations about me.

September-December 2023

Cox has made dozens of Public Records requests to Port Townsend Police Department,

Jefferson County Sheriff, City of Port Townsend, Jefferson County, JeffCom 911 Dispatch and

others, searching for information about me. While she is within her rights to seek public

information, the coordinated, targeted nature of her requests and her use of them to "doxx" and
publish private information such as my phone number, address, address of my friends etc.

constitutes part of an overall pattern of harassment.

September 2023

Ms. Cox made a comment on a public Facebook post from Erik Wennstrom, asking for "whistleblowers" to come forward with information about Salish Rescue. Yet she testified under oath on 2/28/2024 she doesn't know Wennstrom, is not working with him, and has never met or spoken with him.

10+ Year History of Online Harassment and Defamation

Cox has a long history of this type of extreme harassing behavior. A similar case involving Cox's defamation and harassment went all the way to the Federal District Court in Oregon:

Cox has had numerous other victims of similar harassment. In many cases after she has damaged a victim's online reputation, she then attempts to charge that victim for "reputation management services" to remove the defamatory content.

From the New York Times article about Cox:

"Mr. Padrick, a lawyer who is a member of the bar in four states and has never been disciplined or investigated from anything I could find, said he spent a lot of sleepless nights wondering how he ended up as Ms. Cox's bête noire.

"A woman who I did not know, who had no connection to me or my company or with this case she has been making statements on, has turned my business life and personal life upside down," he said. "Companies who are considering doing business with us do a routine search on Google and there is page after page of these allegations. If it can happen to me, it can happen to anybody."

"And it has. Ms. Cox, who calls herself an "investigative blogger," has a broad range of conspiratorial/journalistic interests. She has written that Bruce Sewell, the general counsel of Apple, "aids and abets criminals"; that Jeffrey Bewkes, the chief executive of Time Warner, is "a proven technology thief"; and that various Proskauer Rose lawyers have engaged in a pattern of "conspiracy." And don't get her started on the local officials in and around her hometown, Eureka, Mont.

"When she gets in a fight with someone, she frequently responds by creating a domain with the person's name, some allegation of corruption, or both. Many of the negative posts about Mr. Padrick appeared on obsidianfinancesucks.com and there are many more like it. In order to optimize visibility to Web crawlers, she often uses the full name and title of her target, and her Web sites are filled with links to her other sites to improve their search ranking. She has some 500 URLs at her disposal and she's not afraid to use them."

Cox is actively harassing me, and acting as a proxy for Jennifer Ellison and Erik Wennstrom to harass me. I want no contact with Cox of any kind – I want her to leave me alone, to immediately remove all content mentioning me, Salish Rescue, my image, my name, or any information about me, and to stop posting any kind of online content about me, my Salish Rescue colleagues, or the Salish Rescue organization.

Her defamatory posts are harassment, not free speech. Federal Courts have determined that Cox is not in fact a journalist. I am not a public figure.

Taken all together, these actions constitute an ongoing pattern of harassment. I want this behavior to stop, and am taking advice from law enforcement and the courts, and seeking a protective order.

Attachment A: Definitions (Always include with petition.)

"Domestic violence" means:

- (a) Physical harm, bodily injury, assault, or the infliction of fear of physical harm, bodily injury, or assault; nonconsensual sexual conduct or nonconsensual sexual penetration; coercive control; unlawful harassment; or stalking of one intimate partner by another intimate partner; or
- (b) Physical harm, bodily injury, assault, or the infliction of fear of physical harm, bodily injury, or assault; nonconsensual sexual conduct or nonconsensual sexual penetration; coercive control; unlawful harassment; or stalking of one family or household member by another family or household member.

"Sexual conduct" means any of the following:

- (a) Any intentional or knowing touching or fondling of the genitals, anus, or breasts, directly or indirectly, including through clothing;
- (b) Any intentional or knowing display of the genitals, anus, or breasts for the purposes of arousal or sexual gratification of the respondent;
- (c) Any intentional or knowing touching or fondling of the genitals, anus, or breasts, directly or indirectly, including through clothing, that the petitioner is forced to perform by another person or the respondent;
- (d) Any forced display of the petitioner's genitals, anus, or breasts for the purposes of arousal or sexual gratification of the respondent or others;
- (e) Any intentional or knowing touching of the clothed or unclothed body of a child under the age of 16, if done for the purpose of sexual gratification or arousal of the respondent or others; or any coerced or forced touching or fondling by a child under the age of 16, directly or indirectly, including through clothing, of the genitals, anus, or breasts of the respondent or others.

"Sexual penetration" means any contact, however slight, between the sex organ or anus of one person by an object, the sex organ, mouth, or anus of another person, or any intrusion, however slight, of any part of the body of one person or of any animal or object into the sex organ or anus of another person including, but not limited to, cunnilingus, fellatio, or anal penetration.

Evidence of emission of semen is not required to prove sexual penetration.

"Stalking" means any of the following:

- (a) Any act of stalking as defined under RCW 9A.46.110;
- (b) Any act of cyber harassment as defined under RCW 9A.90.120; or
- (c) Any course of conduct involving repeated or continuing contacts, attempts to contact, monitoring, tracking, surveillance, keeping under observation, disrupting activities in a harassing manner, or following of another person that:
 - (i) Would cause a reasonable person to feel intimidated, frightened, under duress, significantly disrupted, or threatened and that actually causes such a feeling;
 - (ii) Serves no lawful purpose; and
 - (iii) The respondent knows, or reasonably should know, threatens, frightens, or intimidates the person, even if the respondent did not intend to intimidate, frighten, or threaten the person.

"Unlawful harassment" means:

- (a) A knowing and willful course of conduct directed at a specific person that seriously alarms, annoys, harasses, or is detrimental to such person, and that serves no legitimate or lawful purpose. The course of conduct must be such as would cause a reasonable person to suffer substantial emotional distress, and must actually cause substantial emotional distress to the petitioner; or
- (b) A single act of violence or threat of violence directed at a specific person that seriously alarms, annoys, harasses, or is detrimental to such person, and that serves no legitimate or lawful purpose, which would cause a reasonable person to suffer substantial emotional distress, and must actually cause substantial emotional distress to the petitioner. A single threat of violence must include:
 - (i) A malicious and intentional threat as described in RCW 9A.36.080(1)(c); or
 - (ii) the presence of a firearm or other weapon.
